## Upcoming NMLS Enhancements

NMLS Enhancements are scheduled to be released September 12, 2016. Following is a brief overview of the new functionality that will apply to those licensed or seeking licensure in Georgia.

- **Criminal Background Check (CBC) for MU2 Individuals:** As part of a recent Secure and Fair Enforcement for Mortgage Licensing Act of 2008 (“SAFE Act”) amendment, NMLS is now authorized to process background checks for the following individuals:
  - Direct Owners/Executive Officers (DO/EO)
  - Indirect Owners (IO) (with control)
  - Branch Managers

If required, completeness checks and warning messages on the Individual Form (MU2) will direct company and individual users to request a CBC and grant CBC Agency Access.

- Licensees will need to refer to the applicable state licensing checklists to identify when a CBC may be required. ***Be on the lookout for new licensing checklists for Georgia.***
- A guide will be provided for companies and licensees when the functionality goes live.

- **Individual Document Upload:** Individual Forms (MU2 & MU4) will now have a Document Upload section. The following document types will be available for selection if applicable state specific requirements exist.

### For MU2/MU4 filings:

- Credit Report Explanations
- Legal Name/Status Documentation
- Verification of Experience

### For MU2 filings only:

- Personal Financial Statement
- State Background Check Authorization

## Continuing Education Requirements for 2017 License Renewal: Reminder to Mortgage Loan Originators

On or before October 31, 2016, mortgage loan originators (“MLOs”) must obtain 8 hours of continuing education to renew their licenses for 2017.

MLOs approved for licensure that obtained their pre-licensing education (“PE”) in 2016 **DO NOT** have to obtain continuing education for the 2017 license renewal.

Continuing education obtained by MLOs for license renewal must be:

- taken for the required number of hours in the following areas of study:
  - 3 hours in federal law and regulations:
  - 2 hours in ethics, which shall include instruction on fraud, consumer protection and fair lending issues;
  - 2 hours in training related to lending standards for the nontraditional loan product marketplace; and
  - 1 hour in coursework that covers changes made to the Georgia Residential Mortgage Act, O.C.G.A. § 7-1-1000, and its corresponding regulations.

- approved by the Nationwide Multistate Licensing System (“NMLS”) and offered by an authorized person or entity;
- taken in a classroom setting or on-line; and,
- acquired on January 1, 2016, through October 31, 2016.

**Note:** You must allow sufficient time for the CE to be reported before you file for renewal as you will not be permitted to request renewal until all CE required has been reported.

## Mortgage Broker Continuing Education Requirements Eliminated

As noted in the [June 2016 Monthly Mortgage Summary](#), the Department adopted Final Rules on June 20, 2016, that became effective on July 10, 2016.

Among other things, these rule changes eliminated the initial experience and education requirements and continuing education requirements for mortgage brokers previously found in Department Rule 80-11-4-.01.

*For that reason, mortgage brokers will not be required to obtain or report continuing education this renewal season.*

## Preparing for the 2017 License Renewal Period

The 2017 renewal period is fast approaching. As a reminder, all licensee records must be up to date at the time of renewal. Amendments to license information CANNOT be made through the renewal feature. If you need to make changes to a company, branch, or individual record before you attest to its accuracy for renewal, this must be done prior to submitting a renewal request through the *Filing* tab. It is strongly recommended that you submit updates immediately to allow sufficient time for review. Additionally, you should review license statuses and confirm that there are no outstanding license items that need to be cleared, whether placed by the NMLS system or the Department.

Waiting until November or December to submit amendments and/or clear outstanding license items will delay the approval of your renewal request.

## Complaint Contact Information

Applicants and licensees are required to designate a Primary Company Contact as well as a Primary Consumer Complaint Contact.

Each licensee must keep the Department informed of the name and telephone number of the current contact person.

Department Rule 80-11-1-.03(9) states that the "contact person for consumer complaints" referred to in Code Section 7-1-1006 shall be a person who is available and has authority to investigate and resolve questions and complaints from consumers which have come to the department for resolution.
