Continuing Education Requirements for 2017 License Renewal: Reminder to Mortgage Loan Originators

On or before October 31, 2016, mortgage loan originators ("MLOs") must obtain 8 hours of continuing education to renew their licenses for 2017.

MLOs approved for licensure that obtained their pre-licensing education ("PE") in 2016 **DO NOT** have to obtain continuing education for the 2017 license renewal.

Continuing education obtained by MLOs for license renewal must be:

- taken for the required number of hours in the following areas of study:
 - 3 hours in federal law and regulations;
 - 2 hours in ethics, which shall include instruction on fraud, consumer protection and fair lending issues;
 - 2 hours in training related to lending standards for the nontraditional loan product marketplace; and

- 1 hour in coursework that covers changes made to the Georgia Residential Mortgage Act, O.C.G.A. § 7-1-1000, and its corresponding regulations.

- approved by the Nationwide Multistate Licensing System ("NMLS") and offered by an authorized person or entity;
- taken in a classroom setting or on-line; and,
- acquired on January 1, 2016, through October 31, 2016.

Mortgage Broker Continuing Education Requirements Eliminated

As noted in the [June 2016 Monthly Mortgage Summary](#), the Department adopted Final Rules on June 20, 2016, that became effective on July 10, 2016.

Among other things, these rule changes eliminated the initial experience and education requirements and continuing education requirements for mortgage brokers previously found in Department Rule 80-11-4-.01.

Georgia Residential Mortgage Act (“GRMA”) Per Loan Fee Reporting and Payment Process

GRMA Per Loan Fees - The \$10.00 per loan fees required by O.C.G.A. § 7-1-1011(b)(2) and Department Rule 80-5-1-.04 are due no later than September 1, 2016, for mortgage loans closed during the period January 1, 2016 through June 30, 2016.

To avoid fines for failure to remit GRMA fees when due, reporting and payment must be completed online at <https://bkgfin.dbf.state.ga.us/GRMAFee.html>.

Collecting agents submitting GRMA Fees after the due date referenced on Page 1, or for prior semiannual periods, must complete and mail a paper form, along with their payment, to the Department.

REMINDER: Collecting agents that did not close any loans during the semi-annual period do not need to file a report with the Department. **The Department’s online payment and reporting website does not allow reporting of \$0 loans.**

Mortgage Call Report Reminder

This is a reminder that the Mortgage Call Report (“MCR”) required by O.C.G.A. § 7-1-1004.1 is due within 45 days of the end of every calendar quarter. **Second quarter data (April 1 – June 30, 2016) must be filed through the NMLSR by August 14, 2016.**

Companies that fail to file quarterly MCRs prior to the deadline will be assessed a fine and may subject their Georgia license to revocation.
