Georgia's 2017 Mortgage Renewal Checklist

Georgia's mortgage license renewal checklist has been posted to the NMLS Resource Center. Please review the checklist for information on the requirements to renew your license. To avoid a late fee, please renew between November 1 and December 1, 2016.

To complete a renewal request you must continue to meet all licensing requirements of the Georgia Residential Mortgage Act, O.C.G.A. § 7-1-1000, *et seq.* and must attest to that fact and submit a renewal request through NMLS.

2017 Mortgage License/Registration Renewal Timeline

All individuals and companies holding a Georgia mortgage license or registration must submit a renewal request through NMLS starting November 1st if they wish to retain their license to conduct business in Georgia in 2017. Mortgage branches must also be renewed through NMLS.

Streamlined Renewals — Mortgage Company Licensees, Registrations & Branches

All companies holding a Mortgage Broker or Lender License or Registration in Georgia must submit a renewal request through NMLS between November 1 and December 1, 2016. The late renewal period is between December 2 and December 31, 2016; companies may be assessed a \$300 late fee during this period. The NMLS Streamlined Renewal Process allows your company to conveniently manage the renewal of company, branch, and sponsored Mortgage Loan Originator (MLO) licenses through your organization's NMLS account.

Actions Required: Records must be up to date at the time of renewal. Amendments to license information CANNOT be made through the renewal feature. If you need to make changes to a company, branch, or individual record before you attest to its accuracy for renewal, this must be done prior to submitting a renewal request through the *Filing* tab. It is strongly recommended that you submit updates immediately to allow sufficient time for review. Additionally, you should review license statuses and confirm that there are no outstanding license items that need to be cleared.

NOTE: Waiting until November or December to submit amendments and/or clear outstanding license items will delay the approval of your renewal request.

Easy Steps for Renewal:

To complete a renewal request:

- Continue to meet all licensing requirements of the Georgia Residential Mortgage Act (O.C.G.A. § 7-1-1000 et seq.)
- If your company continues to meet these requirements:

- Attest to that fact and submit a renewal request through NMLS.
- Pay the required statutory license renewal fees and NMLS transaction fees (see fee information below).

ADDITIONAL INFORMATION REGARDING RENEWAL REQUIREMENTS

Mortgage Call Report (MCR)

Your company's MCR must be submitted through NMLS for the appropriate quarter(s). No MCR deficiencies can be outstanding. Your renewal request will not be approved if MCR filings are incomplete.

Attestation - Company and Individual

Companies may log onto the NMLS website and complete the attestation process and request renewal starting November 1. Attestation is a company's legal certification that: (i) company and branch NMLS records are up to date, (ii) renewal requirements have been satisfied, and (iii) the company meets all license renewal eligibility requirements.

Companies are required to complete an attestation pertaining to company and branch renewal requests selected for submission each time the Company Renewals Cart is submitted.

NOTE: Companies cannot attest to an individual's MLO license. Once attestation is complete, either the individual MLO or the sponsoring company can submit a renewal request for the license.

Control Persons (Form MU2) do not need to attest to their record as part of a company's renewal submission.

Renewing Sponsored MLOs

If your company will be submitting and paying the renewal request for sponsored MLOs, you can submit the request(s) through the *Renewal* tab in NMLS. The individual must first attest that they continue to meet all licensing requirements, including all continuing education requirements, and that their record is up to date before you can request renewal of their license.

Each individual is required to have completed **8 hours** of Continuing Education prior to being able to submit their renewal request through NMLS. For information on available courses, see the *Professional Standards* section of the *NMLS Resource Center*.

Renewal Submissions Deadlines

Renewal requests may be submitted starting November 1 and should be submitted no later than **December 1**. If you have licenses you do not intend to renew, you must notify the Department by selecting the "Do Not Renew" option.

NMLS WILL NOT ACCEPT RENEWAL SUBMISSIONS AFTER December 31, 2016 (EST).

Please note the time zone difference of your location.

Fees

In addition to Georgia annual renewal fees, NMLS charges processing fees of \$100 per company license, \$20 per branch license, and \$30 per loan originator license. These fees must be paid electronically through NMLS upon submission of the license renewal request. Processing fees cover NMLS' operations, including system access, financial statement functionality, access to reports, the ability to maintain and renew licenses, and call center support.

Training

Renewal workshops will be conducted by the State Regulatory Registry, LLC to review the NMLS 2017 Streamlined Renewal Process. The optional workshops will provide licensees and applicants with tips on how to use the NMLS during the 2017 Streamlined Renewal period. The fee for these workshops is \$75. To register for one of the workshops, visit the State-Licensed Training Workshops page on the NMLS Resource Center.

These fees must be paid electronically through NMLS upon submission of the license renewal request. Requests must be submitted by **December 1**, **2016** for a timely renewal. Renewal requests submitted on or after December 2nd will be considered late and may be subject to an additional \$300 (Company Licensees and Registrations) or \$100 (MLO) late renewal application fee that will be invoiced through NMLS. The above fees do not reflect NMLS processing fees.

Streamlined Renewals — Mortgage Loan Originators

All individuals holding a **Georgia Mortgage Loan Originator License (MLO)** with the **Department** must renew their license through NMLS between **November 1** and **December 1, 2016** if they wish to retain their license to conduct business in **Georgia** in 2017. The late renewal period is between **December 2** and **December 31, 2016**; MLOs may be assessed a \$100 late fee during this period.

Records must be up to date at time of renewal.

Amendments to your record CANNOT be made through the renewal feature. If you need to make changes to your record before you can attest to its accuracy, we strongly recommend submitting any necessary updates through the *Filing* tab immediately to allow sufficient time for the review of changes prior to renewal. In addition, you may wish to review your status and confirm that you have no outstanding license items that need to be cleared. **NOTE:** Waiting until November or December to submit amendments and/or clear outstanding license items may delay the approval of your renewal request.

Renewal Requirements

To complete a renewal request, you must continue to meet all licensing standards for **Georgia**. If you continue to meet these standards, the **Department** requires that you attest to the accuracy of your record, pay the renewal fees (see fee information below), and satisfy all outstanding license items upon submission of your renewal request through NMLS.

Continuing Education

You must have your eight (8) hours of Continuing Education (CE) complete prior to being able to renew your license through NMLS. Georgia's CE deadline is October 31, 2016; a \$100 late CE fee may be assessed if the requirement is not met by the deadline.

You will be prevented from renewing your license if you have not completed your CE requirements for 2016.

Attestation and Renewal Request Submission

Starting November 1, you must log into your NMLS account and attest to your record. Attestation is your legal certification that: (i) your NMLS record is up to date, (ii) renewal requirements have been completed, and (iii) you meet all renewal eligibility requirements. Once attested, either you or your sponsoring company can submit your renewal request.

NMLS WILL NOT ACCEPT RENEWAL SUBMISSIONS AFTER December 31, 2016 (EST). Please note the time zone difference of your location.

Fees

In addition to the \$100 annual renewal license fee that will be charged by Department, NMLS charges a processing fee of \$30 which must be paid electronically through NMLS upon submission of the renewal request.

MLO CE Requirements for 2017 License Renewal

On or before October 31, 2016, MLOs must obtain 8 hours of continuing education to renew their licenses for 2017.

MLOs approved for licensure that obtained their prelicensing education ("PE") in 2016 **DO NOT** have to obtain continuing education for the 2017 license renewal. To find out when and where necessary course work will be offered to satisfy Georgia's continuing education requirements, mortgage licensees should visit the NMLS website at

Mortgage Call Report Reminder

This is a reminder that the Mortgage Call Report ("MCR") required by O.C.G.A. § 7-1-1004.1 is due within 45 days of the end of every calendar quarter.

Third quarter data (July 1 – September 30, 2016) must be filed through the NMLSR by November 14, 2016.

Companies that fail to file quarterly MCRs prior to the deadline will be assessed a fine and may subject their Georgia license to revocation.

Failure to file a timely MCR will also delay the processing of your renewal application.
