### **THE GEORGIA DEPARTMENT OF BANKING AND FINANCE'S ORDER TO CEASE AND DESIST ISSUED TO WOYENGITONBARA "BONNIE" ETETE BECOMES FINAL**

**Atlanta, Georgia** ~ On December 5, 2007, the Georgia Department of Banking and Finance's ("Department's") Order to Cease and Desist issued to Woyengitonbara "Bonnie" Etete of Suwanee, Georgia, became final.

Ms. Etete was issued an Order to Cease and Desist by the Department for making misrepresentations in loan files submitted to mortgage lenders.

Pursuant to state law that was in effect when the violations underlying the Order to Cease and Desist were committed, the Department may revoke the license of a mortgage broker or lender that employs an individual against whom a final Order to Cease and Desist has been issued within the preceding three years if the Order resulted from misrepresentations being made in loan documents.
