COMPANY AFFIANT

VERIFICATION OF LAWFUL PRESENCE CITIZENSHIP AFFIDAVIT INSTRUCTIONS

Pursuant to the Official Code of Georgia Annotated § 50-36-1 *et seq.*, the Georgia Department of Banking and Finance ("Department") is required to verify the lawful presence of every new applicant. This includes corporations, partnerships, limited liability companies and other business structures submitting new license applications.

For Mortgage Broker, Mortgage Lender, Installment Lender, Check Casher, and Money Transmitter company applicants (corporations, partnerships, limited liability companies or other business entities), only one individual, an owner or officer with the authority to act on behalf of the company, must complete and submit a signed, notarized affidavit. The designated individual will be the "affiant," providing affidavit testimony regarding his or her legal presence in the United States.

Sole Proprietor applicants, seeking to obtain a license in his or her own name will provide affidavit testimony regarding his or her legal presence in the United States using the attached Citizenship Affidavit.

Please note that if the designated individual for a company, is not a United States citizen, this Department may be required by O.C.G.A. §50-36-1 to verify their immigration status through the Federal Systematic Alien Verification of Entitlement (SAVE) program. Additional documentation may be requested. Additionally, entity whose affiant is a legal permanent resident, qualified alien or immigrant is required to reverify its lawful presence annually at renewal.

Checklist for Completion

- ✓ Print the name of the company, its NMLS number, as well as the affiant's NMLS number, name and title.
- Check only one of the boxes to indicate the affiant's legal status (U.S. citizen, legal permanent resident, or qualified alien or non-immigrant). A **qualified alien or non-immigrant** must also include his or her federally issued alien number along with a Foreign Passport and I-94, or an Employment Authorization Document that contains a photograph.
- Check one of the secure and verifiable documents that will be submitted to verify the affiant's legal status and attach a legible copy (front and back) to the affidavit.
- ✓ Print the city and state in which the affidavit was executed.
- \checkmark Print the name of the Affiant and his or her title for the company.
- ✓ Affiant should sign the document in the presence of a notary who will affix his or her seal to the document.
- ✓ Submit the original, signed, notarized affidavit along with a legible copy (front and back) of the secure and verifiable document selected to the Department.

Applications will not be processed without a complete and notarized affidavit.
