Continuing Education Requirements for 2019 License Renewal: Reminder to Mortgage Loan Originators

On or before October 31, 2018, mortgage loan originators ("MLOs") must obtain 8 hours of continuing education to renew their licenses for 2019.

MLOs approved for licensure that obtained their pre-licensing education ("PE") in 2018 **DO NOT** have to obtain continuing education for the 2019 license renewal.

Continuing education obtained by MLOs for license renewal must be:

- taken for the required number of hours in the following areas of study:
 - ☑ 3 hours in federal law and regulations;
 - ☑ 2 hours in ethics, which shall include instruction on fraud, consumer protection and fair lending issues;
 - ☑ 2 hours in training related to lending standards for the nontraditional loan product marketplace; and

- ☑ 1 hour in coursework that covers changes made to the Georgia Residential Mortgage Act, O.C.G.A. § 7-1-1000, and its corresponding regulations.

- approved by the Nationwide Multistate Licensing System ("NMLS") and offered by an authorized person or entity;
- taken in a classroom setting or on-line; and,
- acquired between January 1, 2018, through October 31, 2018.

To find out when and where necessary course work will be offered to satisfy Georgia's continuing education requirements, mortgage licensees should visit the NMLS website at <http://mortgage.nationwidelicencingsystem.org/profreq/education/Pages/default.aspx>.

Mortgage Call Report Reminder

This is a reminder that the Mortgage Call Report required by O.C.G.A. § 7-1-1004.1 is due within 45 days of the end of every calendar quarter. **Second quarter data (April 1 – June 30) must be filed through the NMLSR by August 14, 2018.**

Companies that fail to file quarterly MCRs prior to the deadline will be assessed a fine and may subject their Georgia license to revocation.

Georgia Residential Mortgage Act Fee (“GRMA”) Remittance Reminder

GRMA Per Loan Fees (“GRMA fees”), the \$10.00 per loan fees required by O.C.G.A. § 7-1-1011(b) and Department Rule 80-5-1-.04, are due no later than September 4, 2018, for mortgage loans closed during the period January 1, 2018 through June 30, 2018.

GRMA fees are required to be collected and remitted by the collecting agent, which is the entity “listed as the secured party on a security deed or any other loan document.” This requirement exists to ensure that each collecting agent is given proper credit for remitting the required GRMA fees.

The fees along with a fee statement indicating the number of mortgage loans closed by the collecting agent shall be remitted semiannually to the

Department through its online reporting and payment system located at: <https://bkgfin.dbf.state.ga.us/GRMAFee.html>.

Though collecting agents may use third parties to remit the fees and the fee statement to the Department, the collecting agent is still the person responsible for remittance of GRMA fees. Failure of a collecting agent or its third party remitter to timely remit the GRMA fees along with the corresponding fee statement via the online reporting and payment system may result in the imposition of a fine. Furthermore, the Department may return any paper checks received for GRMA fees and, in such case, will not treat the payment as a timely remittance.
