Mortgage Call Report Reminder

The Mortgage Call Report required by O.C.G.A. § 7-1-1004.1 is due within 45 days of the end of every calendar quarter. **First quarter data (January 1—March 31, 2019) must be filed through the NMLSR by May 15, 2019.**

Companies that fail to file quarterly MCRs prior to the deadline will be assessed a fine and may subject their Georgia license to revocation. **Even if there is no activity to report, companies must file the MCR by the deadline to avoid being fined.**

Non-Georgia Branches

No approval is required for mortgage company branches located outside the State of Georgia, but please remember that failure to adequately supervise the operations of any out-of-state branch as it relates to residential mortgage transactions on Georgia property can result in the loss of your license.

Please **DO NOT** submit a [Georgia Mortgage Branch Approval](#) request through the NMLS for branches that are located in a state other than Georgia. Out-of-state branches do not require the Department's approval and SHOULD NOT be submitted through the NMLS in connection with your company's Georgia license. **Fees paid for out-of-state branches filed through the NMLS are non-refundable.**

As always, in-state branch offices require proper approval of both the branch office location and proposed branch manager.
